Welcome to the trials with Microtek Organics.

Before we get too far ahead there are a few things to be aware of that are mentioned below.

How to be successful:

Repetition – Ensure anyone should be able to obtain the same results as yourself from looking at your methodology.

Variables are everywhere. If you are aware of any variable then note it down.

Things to consider for choosing trial location and plants:

Use same camera and camera settings to ensure same image quality.

Consider sunlight and try to ensure that even coverage is throughout the same trial

Consider airflow and air temp (near doors and window may be cooler).

Don't be biased. Try not to choose the worst or the best plants, this includes the control.

Avoid contamination or anything that could potentially skew the results. This could include over spray from other sprays in the area, previous contamination from irrigation lines.

Recorded information is the whole reason trials exist.

Write down and note at least the following:

What growing medium / conditions are the trials on? (Hydroponic, Soil, Glasshouse)

What time of the year will trial commence?

What plants are the trials on?

What plants are the control?

Product/s used?

Application rate /s?

Frequency of application?

Measurable results i.e., Yield, Colour, Qty etc.

Observations and comments.
